It is VERY IMPORTANT that your signature on file in the Supervisor of Elections Office is up-to-date. Florida Statute 101.68 requires that the signature on the Vote-By-Mail Ballot Voter Certificate match the voter signature on file in the Supervisor of Elections office.

The deadline for voted absentee ballots to be returned to the Supervisor of Elections office is Tuesday, November 8, 2016 by 7:00 P.M.

EARLY VOTING DATES AND TIMES FOR NOVEMBER 8, 2016 GENERAL ELECTION

Early Voting Dates and Times for the 2016 General Election are as follows: Monday, October 24, 2016 through Saturday, October 29, 2016 - 7:00 A.M. until 7:00 P.M. Sunday, October 30, 2016 – 10:00 A.M. until 6:00 P.M.
Monday, October 31, 2016, through Saturday, November 5, 2016 - 7:00 A.M. until 7:00 P.M.

Early voters will have reserved parking in the rear of the courthouse. The back door to the Supervisor of Elections office will be open during Early Voting hours. If you choose to come through the main (front) entrance of the courthouse, you will be required to exit through the back door of the courthouse. There will be no entry or re-entry available to the main part of the courthouse from the Supervisor of Elections office which is located in the basement of the courthouse.

If you do not vote early or vote by mail, you must vote at your home precinct on Election Day (F.S. 101.62(4)(c)5) unless you are precluded from doing so by an emergency. If you have an emergency that precludes you from voting at your precinct on Election Day, you will be required to complete an affidavit stating your emergency. Vote-by-Mail Ballot Certificate Envelopes for the November 8, 2016 General Election will be available for public inspection one hour prior to each Canvassing Board Meeting. In order to view Vote-by-

Provisional Ballots cast by voters who did not provide photo and signature identification will be canvassed as signatures are verified. It may become necessary for the Canvassing Board to reconvene at times or places other than those specified above. If so, the location, date and time will be announced at the conclusion of the pertinent meeting and posted in four conspicuous places in Holmes County.
