Acceptable forms of ID include:

- Florida driver's license
- Florida identification card issued by Department of Highway Safety and Motor Vehicles
- United States Passport
- Debit or credit card
- Military ID
- Student ID
- Retirement Center ID
- Neighborhood Association ID
- Public Assistance ID
- Veteran Health ID card issued by the U.S. Department of Veterans Affairs
- License to carry a concealed weapon or firearm issued pursuant to section 790.06, Fla. Stat.
- Employee ID card issued by any branch, department, agency, or entity of the Federal Government, the state, county, or a municipality

Florida law requires that a voter present current and valid picture and signature identification when voting in person. Any voter appearing to vote without identification will be allowed to vote a Provisional Ballot.



UPDATE OF VOTER'S SIGNATURE
(F.S. 98.077)



It is very important for you to keep your signature current with the Supervisor of Elections. Signatures on your registration record are used to verify signatures on petitions, and on provisional and vote-by-mail ballots. If your signatures do not match, your petition or ballot will not count. To update your signature, provide the Supervisor of Elections with a voter registration application indicating a signature update.

FLORIDA IS A CLOSED PRIMARY STATE. WHAT DOES THIS MEAN?

Only voters who are registered members of a political party may vote for that party's candidates in a primary election, **UNLESS** the race is a Universal Primary Contest.

A Universal Primary Contest occurs when all candidates in the same race have the same political party affiliation and the winner will have no opposition in the General Election. In the 2018 Primary, both County Commission races are Universal Primary Contests. Even though County Commission races are partisan, because all six county commission candidates have the same party affiliation, these races will be on the Republican, Democratic and Nonpartisan ballots and **ALL** eligible voters can vote for county commissioner in the 2018 Primary. The county commission races will not advance to the 2018 General Election as they will be decided in the 2018 Primary Election. **ALL** eligible voters can vote in a Universal Primary Contest and School Board Contest regardless of their political party affiliation.

The voter registration books for the 2018 Primary Election close on July 30, 2018. This means that any new voter registration applications or political party changes must be received or postmarked by July 30, 2018.

On Election Day the Polls are open 7:00 a.m. - 7:00 p.m. Before you go to the polls:

- If your address or name has changed, contact the elections office **BEFORE** Election Day.
- Check your voter information card for the location of your polling place.
- Take your drivers license or another form of photo and signature ID to the polls.
